At the Annual General Meeting, resolutions will be proposed, among other matters:

- (a) to grant the Issue Mandate to the Directors;
- (b) to grant the Repurchase Mandate to the Directors;

- (c) to extend the Issue Mandate by an additional number representing such number of Shares repurchased under the Repurchase Mandate; and
- (d) to re-elect the retiring Directors.

The purpose of this circular is to provide you with information in relation to the resolutions to be proposed at the Annual General Meeting for the grant of the Issue Mandate, the grant of the Repurchase Mandate and the re-election of retiring Directors, and to seek your approval in connection with such matters at the Annual General Meeting.

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

The Company's existing mandates to issue and repurchase Shares were approved by its Shareholders on 1 June 2012. Unless otherwise renewed, the existing mandates to issue and repurchase Shares will lapse at the conclusion of the Annual General Meeting.

Two ordinary resolutions, namely Ordinary Resolutions Nos. 5 and 7 in the AGM Notice, will be proposed at the Annual General Meeting to grant to the Directors (i) the Issue Mandate to allot, issue and deal with new Shares not exceeding 20% of the aggregate nominal amount of the share capital of the Company in issue at the date of passing of Ordinary Resolution No. 5 in the AGM Notice and (ii) an extension to the Issue Mandate so granted by adding thereto any Shares repurchased by the Company pursuant to the Repurchase Mandate up to 10% of the issued share capital of the Company as at the date of passing Ordinary Resolution No. 6 in the AGM Notice.

An ordinary resolution will be proposed at the Annual General Meeting to grant to the Directors the Repurchase Mandate, details of which are set out in Ordinary Resolution No. 6 in the AGM Notice. The Shares which may be purchased by the Company pursuant to the Repurchase Mandate shall not exceed 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of Ordinary Resolution No. 6.

As at the Latest Practicable Date, a total of 417,518,668 Shares were in issue. Subject to the passing of Ordinary Resolutions Nos. 5 and 7, the Company will be allowed to allot and issue up to a maximum of 83,503,733 Shares and repurchase a maximum of 41,751,866 Shares on the assumption that there will be no change in the issued share capital prior to the Annual General Meeting.

Subject to the relevant resolutions being passed at the Annual General Meeting, the Issue Mandate and the Repurchase Mandate shall be valid from the date of passing the resolutions until whichever is the earliest of:

- (a) the conclusion of the next annual general meeting of the Company; or
- (b) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws in the Cayman Islands to be held; or

(c) the passing of an ordinary resolution by the Shareholders in general meeting revoking, varying or renewing the authority given to the Directors.

Under the Listing Rules, the Company is required to give to the Shareholders certain information to enable Shareholders to make an informed decision as to whether to vote for or against the resolution to approve the grant to the Directors of the Repurchase Mandate. RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the Board consisted of nine Directors, namely Mr. Wong Shik Ho Tony, Mr. Wong Fong Pak, Mr. Leung Wah Kan, Mr. Ho Nai Nap and Mr. Man Wai Hung, being the executive Directors; Mrs. Ho Wong Mary Mee-Tak being the non-executive Director (Mr. Chiu Wing Yui acting as the alternate Director to Mrs. Ho Wong Mary Mee-Tak); and Mr. Ip Shing Hing, Mr. Lai Kin Jerome and Mr. Cheung Ying Sheung, being the independent non-executive Directors.

Pursuant to Article 108 of the Articles of Association, at each annual general meeting one-third of the Directors for the time being shall retire from office by rotation and shall be eligible for re-election. Accordingly, Mr. Wong Fong Pak, Mr. Leung Wah Kan and Mr. Man Wai Hung will retire from office by rotation at the Annual General Meeting. All of them, being eligible, will offer themselves for re-election.

Accordingly, the chairman of the Company will exercise his right as chairman of the Annual General Meeting under Article 72 of the Articles of Association to demand a poll on each of the resolutions to be proposed at the Annual General Meeting.

The Listing Rules permit companies with a primary listing on the Stock Exchange to repurchase their own shares on the Stock Exchange subject to certain restrictions. This Appendix serves as an explanatory statement as required by the Listing Rules to provide requisite information to you for your consideration of the Repurchase Mandate.

1. REPURCHASE OF SHARES FROM CONNECTED PARTIES

The Listing Rules prohibit a company from knowingly purchasing shares on the Stock Exchange from a connected person (as defined in the Listing Rules) and a connected person is prohibited from knowingly selling his/her/its securities to the company.

No connected person of the Company has notified the Company that he/she/it has a present intention to sell any Shares to the Company, nor has undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders at the Annual General Meeting.

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 417,518,668 Shares.

Subject to the passing of the Ordinary Resolution No. 6 and on the basis that no further Shares will be issued or repurchased by the Company prior to the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 41,751,866 Shares (representing 10% of the aggregate nominal amount of the issued share capital of the Company as at the Latest Practicable Date) during the period from the date of passing of Ordinary Resolution No. 6 set out in the AGM Notice up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws of the Cayman Islands to be held; or (iii) the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting, whichever is the earliest.

3. REASONS FOR THE REPURCHASE

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders as a whole. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value and/or earnings per Share.

4. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds of the Company legally available for such purposes in accordance with the memorandum of association of the Company, the Articles of Association and the applicable laws and regulations of the Cayman Islands, including profits of the Company or out of a fresh issue of Shares made for the purpose of the repurchase or, if authorized by the Articles of Association and subject to the Companies Law, out of the capital of the Company and, in the case of any

premium payable on the repurchase, out of the profits of the Company or from sums standing to the credit of the share premium account of the Company or, subject to the Companies Law, out of capital of the Company.

An exercise of the Repurchase Mandate in full might have a material adverse impact on the working capital or gearing position of the Group as compared with the position disclosed in the audited consolidated accounts contained in the Company's annual report for the year ended 31 December 2012. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital requirements of the Company or on its gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. UNDERTAKING

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their respective associates, have any present intention to sell any Shares to the Company or its subsidiaries under the Repurchase Mandate if such is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules, the memorandum of association of the Company, the Articles of Association and all applicable laws of the Cayman Islands.

7. TAKEOVERS CODE

If, on the exercise of the power to repurchase shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or group of Shareholders acting in concert (within the meaning of the Takeovers Code), depending on the level of increase in it/their interests, could obtain or consolidate control of the Company and become(s) obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, so far as is known to the Directors, Mrs. Ho Wong Mary Mee-Tak, the controlling Shareholder and a non-executive Director, was beneficially interested in an aggregate of 132,750,000 Shares, representing approximately 31.79% of the issued share capital of the Company. Based on such shareholdings and in the event that the Directors exercise in full the power to repurchase Shares under the Repurchase Mandate, the percentage shareholding of Mrs. Ho Wong Mary Mee-Tak in the Company would be increased from approximately 31.79% to approximately 35.33% and an obligation to make a general offer for all the issued Shares (other than those held by Mrs. Ho Wong Mary Mee-Tak and persons acting in concert with her) may arise.

Save as aforesaid, the Directors are not aware of any consequences which may arise under the Takeovers Code as a result of any repurchases to be made pursuant to the Repurchase Mandate.

The Directors have no intention to exercise the Repurchase Mandate to such an extent that it will cause the public float of the Company to fall below 25%.

Mr. Wong is a co-founder of the Group in May 1997. Mr. Wong is responsible for managing the Group's materials management function and sales and business development function of the Group's Electronics Manufacturing Service business. He also sits on the boards of various companies within the Group. Prior to co-founding the Group in 1997, Mr. Wong worked as a purchasing manager at VTech Computers Limited.

Pursuant to a service agreement dated 21 December 2011, Mr. Wong was appointed as an Executive Director for a term of 3 years commencing from 12 January 2012 (subject to retirement by rotation and re-election in accordance with the Articles of Association), unless otherwise terminated by either party by giving to the other not less than three months' prior written notice. Pursuant to his service agreement, Mr. Wong is entitled to an annual salary of HK\$2,910,360 which is determined with reference to prevailing market practice, the Company's remuneration policy and his duties and responsibilities. Mr. Wong is also entitled to an end-of-year bonus in an amount equal to his then monthly salary, a discretionary performance bonus and a discretionary profit-sharing bonus as may be determined by the Board and subject to the review and approval of the remuneration committee of the Board.

As at the Latest Practicable Date, Mr. Wong was interested in 26,915,750 Shares, representing approximately 6.45% of the issued share capital of the Company. Mr. Wong was also deemed interested in 3,300,000 underlying Shares pursuant to options granted under the Pre-IPO Share Option Scheme within the meaning of Part XV of the SFO.

Save as disclosed above, as at the Latest Practicable Date, Mr. Wong does not (i) hold any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; (ii) hold any other position with the Company and other members of the Group; (iii) hold any other major appointments and professional qualifications; (iv) has any other interests in the Shares within the meaning of Part XV of the SFO; or (v) have any relationship with any Directors, senior management of the Company, substantial Shareholders or controlling Shareholders.

Save as disclosed above, there is no other information that should be disclosed pursuant to the requirements of Rule 13.51(2) of the Listing Rules and there are no other matters concerning Mr. Wong that need to be brought to the attention of the Shareholders.

Mr. Leung Wah Kan (梁華根) ("Mr. Leung"), aged 54, was appointed as a Director on 1 April 2010 and was re-designated as an Executive Director and Chief Operation Officer on 24 January 2011. Mr. Leung is a co-founder of the Group in May 1997. Mr. Leung is responsible for the strategic management of the Group's manufacturing operations in China and the product design and development engineering activities of the Group. He also sits on the boards of various companies within the Group. Prior to co-founding the Group in 1997, he worked at VTech Computers Limited for more than 14 years, serving in various capacities from a testing engineer to a general manager. Mr. Leung was conferred a Bachelor of Science in Engineering degree in 1981 by the University of Hong Kong.

Pursuant to a service agreement dated 21 December 2011, Mr. Leung was appointed as an Executive Director for a term of 3 years commencing from 12 January 2012 (subject to retirement by rotation and re-election in accordance with the Articles of Association), unless otherwise terminated by either party by giving to the other not less than three months' prior written notice. Pursuant to his service agreement, Mr. Leung is entitled to an annual salary of HK\$2,978,040 which is determined with reference to prevailing market practice, the Company's remuneration policy and his duties and responsibilities. Mr. Leung is also entitled to an end-of-year bonus in an amount equal to his then monthly salary, a discretionary performance bonus and a discretionary profit-sharing bonus as may be determined by the Board and subject to the review and approval of the remuneration committee of the Board.

As at the Latest Practicable Date, Mr. Leung was interested in 21,250,500 Shares, representing approximately 5.09% of the issued share capital of the Company. Mr. Leung was also deemed interested in 3,300,000 underlying Shares pursuant to options granted under the Pre-IPO Share Option Scheme within the meaning of Part XV of the SFO.

Save as disclosed above, as at the Latest Practicable Date, Mr. Leung does not (i) hold any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; (ii) hold any other position with the Company and other members of the Group; (iii) hold any other major appointments and professional qualifications; (iv) have any other interests in the Shares within the meaning of Part XV of the SFO; or (v) have any relationship with any Directors, senior management of the Company, substantial Shareholders or controlling Shareholders.

Save as disclosed above, there is no other information that should be disclosed pursuant to the requirements of Rule 13.51(2) of the Listing Rules and there are no other matters concerning Mr. Leung that need to be brought to the attention of the Shareholders.

Mr. Man Wai Hung (文偉洪) ("Mr. Man"), aged 47, was appointed as an Executive Director on 24 January 2011. Mr. Man is the co-founder of Manli Technology Co. Limited in 1996. Since 2008, Mr. Man has been the managing director of Manli Technology Group Limited ("Manli Group"), a wholly-owned subsidiary of the Company, and is in charge of the functions of sales and marketing and business development. He was conferred a Bachelor of Arts degree in 1988 by the University of Hong Kong. Mr. Man was previously a director of Vandar Global Limited, a company incorporated in Taiwan and a wholly-owned subsidiary of Manli Group. For the reason that Manli Group would directly sell products to third party customers in Taiwan, a shareholder's resolution was passed on 2 September 2010 by shareholders of Manli Group to wind up Vandar Global Limited, which was dissolved in June 2011.

Pursuant to a service agreement dated 21 December 2011, Mr. Man was appointed as an Executive Director for a term of 3 years commencing from 12 January 2012 (subject to retirement by rotation and re-election in accordance with the Articles of Association), unless otherwise terminated by either party by giving to the other not less than three months' prior written notice. Pursuant to his service agreement, Mr. Man is entitled to an annual salary of HK\$1,557,000 which is determined with reference to prevailing market practice, the Company's remuneration policy and his duties and responsibilities. Mr. Man is also entitled to an end-of-year bonus in an amount equal to his then monthly salary, a discretionary performance bonus and a discretionary profit-sharing bonus as determined by the Board and subject to the review and approval of the remuneration committee of the Board.
